
The above type numbers represent the order groups which include only a few brightness groups. Only one group will be shipped on each bag (there will be no mixing of two groups on each bag).


In order to ensure availability, single brightness groups will not be orderable.




Fig. 2 - Relative Luminous Intensity vs. Angular Displacement




Fig. 3 - Relative Intensity vs. Wavelength




Fig. 4 - Forward Current vs. Forward Voltage




Fig. 5 - Relative Luminous Intensity vs. Forward Current







Fig. 6 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 7 - Reel Dimensions




Fig. 8 - Tape Direction





Fig. 9 - LED in Tape
